State of the State

Monkeypox

• As of July 7, 2022, 141 probable and confirmed cases of Monkeypox have been reported in California. Local health jurisdictions (LHJs) are responding to new Monkeypox cases across the state. CDPH is providing support to LHJs based on requests received.

COVID-19 Updates

- Since April 2022, COVID-19 cases, test positivity, and hospitalizations have continued to increase across California, while deaths have remained low (with an average of <0.1 deaths per 100,000 population across the last seven days).²
- The vaccination rate has held steady, with approximately 71% of people in California fully vaccinated. The rate of vaccination differs by LHJ, with a high of 92% and low of 30% of the jurisdiction's population completing the primary vaccine series Imperial County has the highest vaccination rate in the state (92%).
- LHJs are prioritizing disproportionately affected populations, congregate settings, and children under five years old for COVID-19 outbreak investigations.
- COVID-19 mitigation efforts have been particularly challenging in children under five years old, due to parental vaccine hesitancy and lack of masking. Severe symptoms in this age group have increased with new variants.
- Recent COVID-19 outbreaks have been connected to travel abroad as well as community events (such as prom and graduation). With this community spread, disproportionately affected populations are hit the hardest.
- The health and wellness of people who are experiencing homelessness or who are unstably housed remains a public health priority. Partnerships with Bay Area hotels to offer accommodations for people diagnosed with COVID-19 continue to provide critical support.
- People who have been reached by a case investigator have been receptive and appreciative of long-COVID
 information. Hesitancy and resistance to hear about vaccine information continues to be a common observation
 made by case investigators.

Other Emerging Topics

- Amador and Calaveras Counties have reported a wildfire named the Electra Fire possibly sparked by fireworks over the Fourth of July holiday weekend. As of July 12, 2022, the Electra fire had burned over 4,400 acres and at least 100 residents in communities near the fire along the Mokelumne River, Southeast of Jackson, have been evacuated.⁴
- Mariposa County has reported a wildfire named the Washburn Fire which began on July 7, 2022. This fire near Yosemite National Park has burned over 3,000 acres.

What are the signs and symptoms?

COVID-19

- **MONKEYPOX**
- Rash with firm bumps on face, hands, feet, body, or genitals
- Fever
- Swollen lymph nodes
- Chills
- Low energy

- Fever
- Cough
- Trouble breathing
- Stomach issues
- Headaches
- Muscle aches
- Loss of taste and smell
- Cold symptoms
